Broad coalition organizes to conserve endowment lands in the NorthFork Payette River basin

Payette Endowment Lands Alliance, 208-520-7708 (MCCALL, ID) – United Payette, a coalition of local and regional stakeholders, has formed to spearhead a transparent and inclusive process to conserve Idaho's endowment lands in the North Fork Payette watershed.

Community opposition to recent proposals seeking to privatize state endowment lands surrounding Payette Lakes has been strong. Currently, United Payette is focusing on proactive, community-based conservation solutions to protect habitat, water quality and ensure continuedrecreational access to lands in Valley County.

The Idaho Constitution mandates that the state Land Board manage endowment lands to maximize long-term returns. United Payette is coordinating with federal, state, county, and city government officials to help the Land Board fulfill this constitutional mandate while conservingthe landscape and maintaining traditional uses for Idahoans.

"Idahoans love this landscape. State lands across the region provide equal and equitable public access for hunters, anglers, hikers, bikers, skiers, and more. The forests, streams, wetlands and meadows provide intact habitat for big game and nongame wildlife species and protect the water quality for the Payette Lakes and Lake Cascade. United Payette is seeking solutions now that will prevent poorly planned development tomorrow. Ultimately, we want to protect the outstanding quality of life and public lands that make this region so special," said Brian Brooks, Executive Director of the Idaho Wildlife Federation.

"These lands provide for 'a way of life' for many Idahoans. All my life I have lived with the forested backdrop of Payette Lake and am committed to ensure that future generations can enjoy the beauty and tranquility of our region. I can't imagine looking out on this beautiful lake seeing luxury housing developments dotting the hillsides and lakeshores," said Debbie Fereday, President of the Payette Endowment Lands Alliance.

"Working together, we must acknowledge the reason why this region is special. The health ofour economy is tied to the public lands of Valley County and we need to provide balance between development and conservation," said Valley County Commissioner Dave Bingaman.

United Payette is currently working with local, regional, state and federal decision makers to implement conservation strategies and funding mechanisms that can satisfy the Idaho Land Board, Idaho Department of Lands and other partners, while protecting the region's quality of life.
